This benefit does not include review of the abstract and preparation of a Title Opinion thereon nor the Provider Attorney's presence at closing. **Uncontested Separation:** Uncontested separation is defined as a separation in which neither you nor your spouse is represented by separate counsel and all issues are agreed upon in writing by the parties without negotiation by your Provider Law Firm. **Uncontested Divorce:** Uncontested divorce is defined as a divorce in which neither you nor your spouse is represented by separate counsel and all issues are agreed upon in writing by the parties without negotiation by your Provider Law Firm, net assets of the marriage are under \$500,000 and no division of retirement benefits is applicable. **Uncontested Adoption:** Uncontested adoption is defined as an adoption in which all parties have agreed in writing to the adoption, all required consents are attainable and the adoption is not contested or challenged. **Uncontested Name Change:** Uncontested name change is defined as a name change in which all consents are attainable and the name change is not contested or challenged.

Additional Information:

It is up to the Provider Lawyer's professional judgment as to whether or not your claim, defense or legal position may prevail in court or is frivolous/without merit. Emergency services are subject to conditions imposed by the detaining/questioning authority.

****After initial consultation, the following are covered under your 25% discount:**
