- What is the solution when you do all the things and still get no response from the parent? Do they truly have the capacity?
  - Get persistent with the personalized communication, reach out to additional family members. Just keep communicating in hopes that they will trust you. We don't know what their capacity is. Equal partnership between teacher and parent.
- Inequity, underserved and equity-please define.
  - Underserved communities where they may be large numbers of migrants, for example, not receiving what they need to succeed.
  - Equity making sure everyone has what they need. Not providing the same thing to all.

- Inequity providing communities what we think they may need not what they actually need.
- Is there a limit to how many people are on the SAC?
  - There is no limit! However you may set a limit at your school.
- Can we require SAC members to volunteer? How do we avoid having members that just join to make changes within the school, outside of the SAC priorities?
  - Make sure you make the purpose of the SAC clear to all members.
  - Set the agenda and stick to it. Enforce the agenda. Allow for questions/suggestions to be emailed to the SAC.
